

Rules and Safety Regulations

SEC Ranch Hours of Operation:

Dawn to Dusk (unless authorized)

Notice of Required Release and Waiver:

- *Anyone* riding, handling or caring for any horse **MUST** have a Use Agreement & Release on file at SEC.
- Minors must have a release signed by both parents (if applicable) and their guardian.

Barn Services:

- Lessons are available **ONLY** with a SEC or SEC approved Trainer.
- If you have Special Needs or require a change be made in the management of your horse, either short term or long term, you must speak directly with SEC management, Jeanne Williams or Maddie Augustsson. The staff is not permitted to make changes or special arrangements on their own.

Vehicles:

- The speed limit on the SEC grounds is 10 MPH.
- When parking cars, trucks or trailers do not block driveways or entrances to any building.
- Parking your trailer for loading and unloading horses should not be done on any of the asphalt.
- Parking your car, truck or trailer at SEC is at your own risk; SEC is not responsible for damage to or theft of vehicles or their contents.
- All trailers left on the property must be registered and approved by the SEC office. Trailer parking is in designated areas only.

Animal Policies:

- SEC Dogs only allowed on facility premises (unless otherwise authorized). If authorized, dogs must be on leash at all times, and may not enter the barn area or any of the horse training areas.
- No horses other than members of SEC, those boarding at SEC or in training with a trainer at SEC or attending a sanctioned function at SEC are allowed on the premises without approval by the management.

Riding Attire Requirements:

- ASHA approved headgear with fastened chin strap is recommended for all clients and required on all minors (under 18 years old) while riding or driving.
- ASHA approved headgear with fastened chin strap is required on all riders regardless of age while jumping.
- Riding boots or shoes with a defined heel are required when riding. Bare feet, sandals or open shoes are not appropriate when working around horses.

Barn Management:

- We **REQUIRE** that all horses in stalls without turn-out be exercised a **MINIMUM** of 30minutes every other day. If you do not ride, lunge, or walk your horse it will be done for you. **NO NOTICE WILL BE GIVEN**, refer to fee schedule.
- Pasture turnout must be administered by SEC staff only.
- Because we share tackroom and storage space please make sure your **NAME** is on all your equipment & belongings.
- Please conserve energy by turning off unnecessary lights in the barn and tack rooms when no one is present.
- **SMOKING IS PROHIBITED** in or near all barns and dwellings.

Barn Upkeep:

- Clients are expected to clean up after themselves around the grooming stalls, wash rack, in the bathrooms and kitchen.
- The Public areas including the refrigerator will be cleaned regularly. Spoiled and unlabeled items will be thrown out or placed in the lost & found.

Storage & Tack:

- Each stall is provided a saddle rack, bridle rack, and limited area for storage of belongings.
- Tack trunks or other storage compartments are allowed only as space permits and approved by management.
- No storage of trunks, boxes or loose supplies will be allowed in barn aisle ways.

Behavior:

- **Courtesy between clients, trainers, visitors and the management is expected at all times.**

These rules are set in place for the safety of SEC clients, and visitors. We appreciate your cooperation and hope you enjoy your time here at SEC! All rules and regulations will be enforced at all times.
